How KVAR®EC units work:

The **KVAR®EC** unit saves electricity by reducing the amount of power used by inductive equipment. Inductive equipment is any device using a motor to operate. All motors use more electricity than is needed to operate. Electrical engineers call it "non-productive current". That's why motors are hot to the touch....the excessive, unused current is expressed as heat.

- Compressors, Pumps, Large Motors, Florescent Lights
- Refrigerators, Freezers, Air Conditioners, Washers & Dryers

- **KVAR** patented a device and methodology for determining, to an exact science, the amount of capacitance that is needed to optimize inductive motors to unity for maximum savings.
- **KVAR®EC** fine tunes the electrical system from the inductive equipment back through the utility company's KVA electric meter, kilowatt hour meter (kWh) or demand meter. This fine tuning slows down the operation and therefore reduces electrical consumption.
- **KVAR®EC** stores the reactive power to create the electromagnetic field (EMF) around the inductive windings of a motor.
- Reactive power is "pulled" and "pushed" to/from the **KVAR®EC** by the motor at 60 cycles/second as the motor operates.
- **KVAR®EC** stores and releases what the motors need to function more efficiently.
- This unique approach serves to reduce the heat generated on the lines plus reduces the strain placed on all the electrical components.
- The **KVAR®EC** stores and supplies power to all inductive loads.

Installation is quick and the savings immediate.

Frequently Asked Questions

What is Power Factor?

Power factor is the percentage of electricity that's delivered to your house and used effectively, compared to what is wasted. For example, a 1.0 power factor means that all the electricity that's being delivered to your home is being used effectively for its purpose. However, most homes in America today have a .77 power factor or less. This means that 77% of the electricity that is coming thru your meter at your home or business is being used effectively, the other 23% is being wasted by your inductive load. With a low power factor, the utility has to deliver more electricity to do the same work. However, the **KVAR®EC** unit increases that power factor in most cases to .97 or .98, thus increasing the effective use of your electricity and lowering your usage.

Will KVAR®EC harm anything in my home or business such as my computer, back-up generator, solar power or anything?

Absolutely not. Your **KVAR®EC** unit has no negative effect on electrical devices. **KVAR®EC** has a very positive effect on the power source by enhancing the capacity of the power source because less amps and watts are being utilized.

Is the KVAR®EC tested and approved by independent labs?

Yes, the **KVAR®EC** is UL listed and tested, CSA approved, NASA tested, has a level 4 Cleaner and Greener rating, is RoHS compliant and is recognized by the U.S. Department of Energy.

How long will it take for the KVAR®EC to pay for itself?

Generally about 6-12 months, but again, the same factors above apply, some will see sooner (6 months), some will see later (12 months).

Is the KVAR®EC easy to Install?

Installation must be done by a licensed electrician.

How long will the KVAR®EC last?

KVAR®EC units are designed to last approximately 20 years.

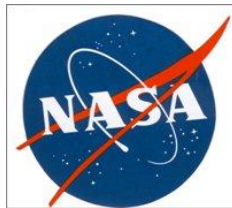
What About KVAR®EC for Surge Protection?

Your KVAR®EC panel unit will save a minimum of 6% off your average Kwh consumption over a period of 12 months (compared to 12 months prior to installation) or we will buy it back at full purchase price.

The guarantee is for panel units only and must be properly installed by a licensed electrician in accordance with our installation procedures. During the first 12 months after installation, all things must remain approximately the same as they were for 12 months prior to installation within the home where KVAR®EC is originally installed meaning no major energy consuming additions are made to the building of original installation. This guarantee is given in addition to your Comprehensive 12-year KVAR®EC Factory Warranty.

KVAR®EC 12-Year Residential Factory Warranty

KVAR ENERGY SAVINGS, INC. provides that, if within twelve (12) years from installation date, this product fails due to a defect in material or workmanship or damage by lightning, KVAR will repair or replace the affected unit free of charge.

This warranty does not apply to damage caused by:

- (A) Accidental mishandling, dropping or other types of physical abuse.
- (B) Units opened, taken apart or subjected to unauthorized repair.
- (C) Units not installed or used in accordance with instructions.
- (D) Riots, civil disturbances, war or other related acts of God.

This warranty does not apply to damages claimed in excess of the cost of the installed units, and although this warranty outlines specific legal rights, your actual rights may vary from state to state.
